CILT Sri Lanka Holds 2018 International Conference



The Chartered Institute of Logistics and Transport (CILT) Sri Lanka hosted its Annual International Conference (IC) 2018 titled 'Staying Relevant in a Digitally Connected Future' in Colombo.

In the opening remarks of the Conference, CILT Sri Lanka Gayani Chairperson, De Alwis, highlighted the main objective of the conference, saying that it is to bring together the logistics and transport fraternity and expose them to new developments in the industry through an expert panel of speakers while providing networking opportunities.

Minister of Transport and Civil Aviation, Hon. Nimal Siripala de Silva, graced the occasion as the Chief Guest. Professor Rohan Samarajiva, Chair of ICT Agency Sri Lanka, delivered the keynote oration by sharing his thoughts on current and potential digitalisation changes that are taking place in Sri Lanka in logistics and transport.

Ravind Mithe, Principal Consultant of KPMG, delivered a speech on "Supply Chain for a Digital World" which consisted of empirical evidence and data from numerous studies together with his perception on the benefits of digitalization in global logistics and transport industry. Rodrigo Reyes, Regional Manager, Airports Passenger Cargo and Security Asia Pacific for IATA, presented on "Simplifying"

Aviation Business" elaborating on the digitalization of the aviation sector. Eva Chang, Head of International Business, Dagang Net Technologies Sdn Bhd, shared her experience in Malaysia on port digitalization and the concept of single window. Dr. Ashan Amarasinghe's presentation "Mass Customization Driven Connectivity and the Emergence of Integrated Smart Logistics" covered on the digitalization and technology usage in the land transport sector in Sri Lanka. David Houser, Senior VP International Sales & Operations, HighJump, forwarded his handson experience in digitalization and technology usage in warehouse operations and management.



We are in times of great change as well as challenges. Digitally driven disruptions are changing our lives and the way we do business. Digital connectivity is transforming transport, logistics and supply chain. We have seen new digital entrants like Alibaba, Airbnb, Uber and our very own PickMe and Kapruka challenging the established and winning. Humans, on average touch the mobile 300 times a day, not only to make calls but to do many other things like paying the bills, buying goods, tracking our route etc. In the world of IoT, our refrigerators will decide and order things by observing our consumption patterns. When you need something, one can order on line and it gets to your doorstep in a few minutes through drone delivery. We are seeing rail travel at 300 km/h.

Yet in Sri Lanka we are still between an analog and a digital world experiencing the discomfort of the former and hoping for the latter. To stay relevant means we understand what is available, what scenarios are emerging and what we need to do for the change to happen. At CILT Sri Lanka, we want to ensure that our membership stay current and relevant and our members who are the leaders in the industry here are equally equipped to bring about the desired change. We cannot sit at the side, but need to be at the center and embrace the change to transform ourselves through digitalization, which is a great equalizer for a small island nation. We must disrupt ourselves before we get disrupted," Gayani further stated at the IC 2018.





L. S. DE SILVA MEMORIAL LECTURE

The Chartered Institute of Logistics and Transport (CILT) Sri Lanka organized the L. S. De Silva Memorial Lecture on 8th of November at 5:30 p.m. at The Institution of Engineers Sri Lanka, Wijerama Mawatha, Colombo 7. The lecture was titled "Transport & Logistics: The need for Public-Private-Partnership Framework and Cooperation" and delivered by Mr. Thilan Wijesinghe, Chairman of the National Agency for Public Private Partnerships (NAPPP), attached to the Ministry of Finance.

Welcoming the gathering Ms. Gayani de Alwis, Chairperson CILT Sri Lanka mentioned how late Eng. L. S. De Silva started the linkage with then CIT in UK as a corresponding member and later as the Founding Chairman of CILT Sri Lanka in 1984 and appreciated his yeoman service rendered to CILT. Mr. Ibrahim Saleem, Council Member CILT Sri Lanka moderated the Q&A session.

Mr. Wijesinghe's presentation contained insightful information and empirical evidence in support the subject topic. He stated that while UNCTAD rates Sri Lanka as 15th best connected in the world for port related activities, Sri Lanka seems to have a comparatively uncompetitive and inefficient logistics environment, as can be seen from the Logistics Performance Indicator (LPI) ranking comparison below:

Sri Lanka also appears to have much to be desired in its "Ease of Doing Business" indicators:

- According to overall "Ease of Doing Business," Sri Lanka ranks 110, ahead
 of South Asian countries, but is well behind East Asian countries, UAE and
 Mauritius.
- Sri Lanka ranks 158th out of 181 under "Paying Taxes" and has 47 types of taxes compared to 9 in China and Malaysia.
- Sri Lanka ranks at 163 (behind Bhutan, Maldives, Nepal and Pakistan) on time taken to enforce a contract through Courts (over 1200 days).
- Sri Lanka's fiscal balance position ranks at the 143rd position out of 193 countries.

Mr. Wijesinghe defined PPP as a special contractual arrangement between a public sector Ministry, corporation or authority, and a private company for providing a public infrastructure asset or service, in which there is an appropriate transfer of risk to the private party and where the private party bears investment and management responsibility on a long-term basis.

In a PPP, the private partner is typically tasked with the design, construction, financing, operation and management of a capital asset to deliver a service to the government or directly to private end users. The private partner will receive either a stream of payments from the government or through charges levied directly on the private end users, or both, for its efforts in undertaking the investment and risks associated with such investment.

What is not a PPP?

- Is any project where the GOSL provides a direct sovereign guarantee to the lending institution of the private partner's debt?
- The GOSL or any of its institutions finances by itself (either through public funds, loans, grants, gifts, donations, contributions or similar receipts) the procurement of a good or service.
- Outright sale of the freehold title or long-term lease of any GOSL asset on CV's valuation.
- Projects where the GOSL retains wholeof-life asset risk. In a PPP, whole-of-life asset risk is retained with the private partner.
- Projects where there are no ongoing post construction performance standards to be met by the private partner.

Why is a central agency for PPPs necessary?

- The third source of financial resources to stimulate capital formation
- Project risk assessment and the equitable allocation of risk between the public entity and the private entity is a responsibility of the NAPPP
- Oversight of the Ministry of Finance is essential to ensure fiscal cost and fiscal risk and recourse to the to the national capital budget if any is optimized
- Line Ministries and Private sector requires single facilitation point
- Tapping into Technical Assistance funds for feasibility studies etc.,
- Tapping into Viability Gap Funding



The Chartered Institute of Logistics and Transport (CILT) Sri Lanka held its 16th John Diandas Memorial Lecture on 04th October 2018 at the Institution of Engineers, Sri Lanka.

John Diandas (Hon. FCIT) known as "Mr. Transport" the world over passed away on 15th July 2002. He was a British citizen born in India in April 1924. He was well known for his extensive knowledge of transport, especially public transport, across the world.

From its inception the annual John Diandas Memorial Lecture (JDML) was delivered by leading professionals, most of whom who knew John personally.

This year's lecture was presented by Dr. Don Jayaweera, Transport Economist/Financial Analyst, Project Management Associate International (Pvt) Ltd., who critically evaluated the topic, "Can We Restore the Lost Market from Bus Passenger Transport System Through Bus Sector Reforms?" He outlined the reform attempts in the bus sector, unresolved supply side issues which are part of bus sector reforms, and key features of the SAHASARA bus passenger reforms project, followed by the evaluation of some of the transport development projects and proposals.

detailed statistics in the presentation showed background information which consist of economic data, basic market demand on car ownership and fuel consumption of transport sector. Further, Dr. Jayaweera emphasized the effect on traffic, highlighting the fact that "the operated vehicle kilometers has increased, but not the passenger kilometers" during the recent past. He added that the estimated average congestion cost in Colombo Metropolitan Area per day has increased approximately to one billion LKR.

Then he deliberated on bus sector reform strategy for 2018 under conceptual outline of SAHASARA which is identified as a cost-free solution for the national transport

problem. The basis for SAHASARA is that the total daily income of a bus operator should not depend on the number of passengers who board that particular bus. Rather, it should be determined by the total take of all buses plying a route on a given day which should then be fairly distributed among all operators based on the total number of turns each bus plied its route.

The Q&A session of the event was interesting and interactive with the participation of many stakeholder which was been moderated by Dr. T. Sivakumar, Senior Lecturer, Department of Transport and Logistics Management, University of Moratuwa. The audience raised many questions on the details of the SAHASARA project and made a number of constructive suggestions for consideration in its implementation. Some of the industry leaders such as Prof. Amal Kumarage, FCILT and Dr. Lalithasiri Gunaruwan. **FCILT** actively participated in this fascinating session.



CHINA INTERNATIONAL LOGISTICS DEVELOPMENT CONFERENCE

A three-member Sri Lankan delegation from the Chartered Institute of Logistics and Transport (CILT) Sri Lanka was invited to the fifth China International Logistics Development Conference in Changsha, the provincial capital of Hunan Province, from 16th to 17th November 2018 at the Kempinski Hotel. Collective Prevention of Marine Degradation

Admiral Jayanath Colombage is a former chief of the Sri Lanka Navy who retired after active service of 37 years as a four-star Admiral. He is a maritime security practitioner/specialist with wide experiences in countering maritime terrorism. He was the former Chairman of Sri Lanka Shipping Corporation and an Adviser to the President of Sri Lanka on Maritime Affairs. He is a Fellow of the Nautical Institute, UK. Admiral Colombage is currently the Director of the Centre for Indo-Lanka Initiatives of the Pathfinder Foundation.



Q. What are the main concerns with marine environment in a global perspective?

First of all, we don't see the damage we do to the ocean. When we don't see what is wrong, we don't understand or take countermeasures to prevent negative impacts. Our long time belief has been that the ocean is vast and we could dump anything into it. However the truth is, dumped plastic, nuclear waste, sewage, garment waste or anything that destroys the ocean life, do come back to us. For an average person ocean means the beach and he or she is not aware of what is called 'maritime blindness'. Lack of knowledge, lack of interest and maritime blindness of majority of the nation are the reasons for continuing damages to ocean. However, signs such as lack of crops, extreme rain or drought and fluctuating weather patterns are there if we look for them. Ocean is a balance itself. It produces 50% of Oxygen, absorbs heat from sun and man-made systems, and absorbs 40% of Carbon dioxide which are vital exchanges to survival of life on earth. This means, if we destroy the ocean, we destroy ourselves.

Q. What are the global initiatives related to marine environments?

Ocean is a global resource. All oceans are connected and hence looking at it with limitations is quite unhealthy. Ocean damage could happen at one place but its ramification could be seen or felt somewhere else. Therefore, we all have a role to play. In 2015, the United Nations introduced new Sustainable Development Goals and its 14th goal is 'Life below Water'. This goal specifically focuses on the ocean with several guidelines to follow and deadlines for each which could be considered as the best initiative so far.

It is also important to raise the individual awareness and education level. at country According to statistics, Sri Lanka is one of biggest culprits of per capita dumping into the ocean. However, we are capable of stopping this damage starting from preventing disposal of small plastic items going to the ocean. Plastic does not degenerate but break into small pieces called 'micro-plastics'. When this happens, there is a tendency for fish to eat these with other food, and when we eat the fish ultimately, plastic enters us our bodies causing many illnesses. Therefore, educating, especially the young population, and making them mindful of ocean damage is very important as it is more of their future where changes could be seen in the long term. Even some particles of chemicals we use end up in the ocean making it more acidic and impacting marine life. Therefore looking for alternatives which are ocean friendly preventing acidification and absorption of unnecessary heat are major requirements today.

Q. What is the prevailing health of the marine environments in the region?

There is a massive garbage patch getting accumulated towards the south of Sri Lanka in the Indian Ocean, and if another tsunami were to happen, all that garbage could come towards us. There is a 60,000sqm dead zone near the Bay of Bengal where further addition of acidic pollutants could expand it, threatening marine life. Similarly, we must be cautious of global warming and consider a shift towards renewable energy. More we burn fossil fuels, the more we keep adding substances

to the atmosphere and depleting the ozone layer. As a result the temperature rises and this effect is already visible with melting ice glaciers in the Arctic.

In Sri Lanka, we have lovely beaches and two monsoons which balance these beaches by nourishing and eroding those alternatively. However, we must focus more on coastal conservation. The law of the country should be upheld on coastal conversation. Today,

many unauthorized structures could be seen on beaches. This disturbs the natural phenomena of beach building. People should not be allowed to misuse or abuse systems, and bypass the law. By law, the beach belongs to the public and not to private bodies. Likewise, single use plastic has become a convenient luxury. We import plastic and dump it here. Therefore, Sri Lanka has not been very careful with implementation of law and policies. We have

too many organizations acting individually on the ocean but lacking the collective coordination. In countries like Thailand, Singapore and Australia, organizations leading in marine environment are linked and coordinated making it more effective. Discussions on marine environment alone are not sufficient but the law should be implemented preventing usage and dumping of pollutants to the ocean.

Q. Are the marine protective initiatives being actively practiced in Sri Lanka?

The initiatives are not being practiced much mainly because they are hard to do single handed. Although remedying or restoration of the current situation is possible only with regional or global effort, locally we can always prevent further degradation. We can promote marine education. There are only a few marine scientists in the island to do research. There is a need to incentivize marine education through scholarships and attractive jobs. The country needs more knowledgeable people to device policies and link them with law of seas. In Sri Lanka only a handful of legal experts are capable of understanding maritime law. Maritime law is only there as an elective subject in local universities which lacks demand due to comparative less opportunities. Learning should come from countries such as Sweden and Norway as they spend much more on oceanography and ocean research and offer their services to other countries as well. Currently, Sri Lanka does not own any mechanisms or survey vessels to collect advanced data and there is no sufficient capability to evaluate or model these data. Hence, the Government should invest more on marine scientific education. There is also a need to develop a Marine Research Centre in Trincomalee focusing on the Bay of Bengal which

is still considered as a rich marine zone. Although it is hard in one life time to reverse the damage along with vulnerable factors such as heat and algae bloom, preventing further degradation is a necessity.

Q. What are the country case studies in the region which Sri Lanka can look upon?

Best country case studies are Mauritius and Seychelles. They are well ahead, including in blue economic concepts in their while legislation, re-growing corals and recognizing complete preserved coastal areas. Another exemplary country is Bangladesh, which plays a leadership role in blue economy of the region. These countries have already been threatened by the ramifications of global warming and ocean level rising due to their low line areas, constant flooding and cyclones. they understand importance of marine life than

other countries which are currently safer. India also has taken admirable effort with policy level discussions. Unfortunately Sri Lanka has been quite slow on these terms but now organizations such as Bandaranaike Centre for International Studies, Lakshman Kadirgamar Institute, Pathfinder Foundation are taking initiatives and holding discussions to gather and share knowledge. Having a Director General for Ocean Affairs and Climate Change in the Ministry of Foreign Affairs could be viewed as a healthy factor as well. Nevertheless, rising of ocean temperature by 13% than scientists anticipated and constantly accelerating global warming require us to be more active and collectively preventive on ocean health.



GREENING SUPPLY CHAINS FOR A SUSTAINABLE TOMORROW

Behind every product or service is a supply chain. A supply chain consists of all parties involved, directly or indirectly, in fulfilling a customer demand. In doing so, supply chain professionals have a moral obligation to mitigate its environmental impact.

Converting the linear thinking to a 'cradle to cradle' approach, is viewing the entire value chain as a sustainable ecosystem. A green supply chain ensures that each stage is addressed as per its environmental footprint including a reverse supply chain.

If companies aspire to achieve superiority over competition, greening supply chains will definitely be a key differentiator. Following are a few green supply chain management practices from product design to shelf:

GREEN DESIGNING

This requires eco-friendly features to be incorporated to the design. Avoiding toxic and hazardous substances, complying with Design for Environment and Design for Disassembly, Reuse & Recycle principles, energy and resource efficiency are other attributes of green designing.

GREEN PROCUREMENT

This involves selecting minimum adverse products and services for manufacturing, transportation, usage, and recycling. Practicing Total Cost of Ownership (TCO) supporting vendors to reduce emissions, sourcing materials through sustainable local sources, guiding on less hazardous materials are sub green procurement initiatives.

GREEN MANUFACTURING

The production processes with green credentials or having "Leadership in Energy and Environmental Design" (LEED) certified will have relatively low environmental impacts comparatively.

GREEN DISTRIBUTION

Green logistics i.e. better packaging for rearranged loading pattern, better use of space and less handling, route optimisation, low emission vehicles and biofuels to power vehicles will reduce the impact to the environment.

Furthermore, Reverse Logistics and Green Retailing are emerging with increase in shopper awareness on environmental impacts of their sources. As an example, in the United Kingdom, Tesco stores are using renewable energy to power their stores. This has also led to winwin results for organisations despite many barriers they have to overcome. The greening process may not bring immediate benefits, but with time this has proven to give confidence to do greater improvements, yielding better results in the long run.

Launching of National Sustainability Discourse

The National Sustainability Discourse, a three month nationwide discussion on the contents of the first draft of the Vision 2030 document was launched in early August by the Presidential Secretariat.

It was expected that following this discourse, the draft document would be revised with public input to create a consensual national vision to map out the sustainable development policies leading up to 2030.

According to Government sources, this would be Sri Lanka's first national effort to create a blueprint to set out the country's long term economic, social and environmental goals for the next 12 years, reflecting on the country's strengths and capabilities.





Volkswagen Group joins Clean Shipping Network

German automaker Volkswagen Group has joined the association of cargo owners, Clean Shipping Network. With this move, the company will use the Clean Shipping Index (CSI) assessment tool in the future to analyse and reduce the environmental impact of marine shipment.

The index includes carbon dioxide (CO2), nitrogen oxide (NOx) and sulfur oxide (SOx) emissions along with chemicals and waste disposal. Members of the Clean Shipping Network will be able to determine the emissions of individual ships and individual routes using the index tool.

World Bank to invest \$200bn to combat climate change

The World Bank is to make about \$200bn available to fund action on climate change from 2021-25, helping countries adapt to the effects of warming and reduce greenhouse gas emissions.

The sum represents a doubling of the five-year investment plan put in place after the landmark Paris agreement of 2015.

Of the \$200bn, half will come in direct

funding from the World Bank and half will be loans and other forms of assistance from other parts of the World Bank group, aimed at mobilising further finance from the private sector.

For instance, some funding will go towards providing early-warning systems and high-quality weather forecasts, which is expected to help 250 million people in 30 developing countries prepare for extreme weather.



Further funding will go towards "smart agriculture", which is better adapted to the expected changes in weather and will help protect food production in some of the worst-affected developing countries. It will also help to protect 120m hectares of forest.

More than 800m people need to travel 30 mins for safe water

Water inequality is increasing in the world's most environmentally stressed nations, warn the authors of a report that shows more than 800 million people need to travel and queue for at least 30 minutes to access safe supplies.

Despite an overall increase in provision of tap water, the State of the World's

Water 2018 reports gaps within and between nations, as poor communities face competition over aquifers and rivers with agriculture and factories producing goods for wealthier consumers.

According to the report, the worst affected country is Eritrea, where only 19% of the population have basic access

to water. It is followed by Papua New Guinea, Uganda, Ethiopia, the Democratic Republic of the Congo and Somalia, all of which have rates of between 37% and 40%. It is no coincidence that many of these nations have large numbers of refugees living in temporary shelters.
